HORSE TRAINING SERVICES:

What would you like to be able to do with your horse at the end of 30, 60, 90 days? We train Monday-Friday and horses receive around 20 training sessions in a month's time. More sensitive horses can benefit from extra days off, horses needing fitness can benefit from more days on. Not all colts are ready to be ridden in the first 30 days, but most are. Many horses handle being saddled and sat on in the first week but each horse is an individual that needs to progress at whatever pace poses least risk of harm to horse and rider.

Vices and Quirks: (ex. Pulls Back, Scared of Vet, Trailer loading, Cribs, Stall Walks, Kicks, Bites, Can't Touch Ears, Hard to Catch)

We teach horses to hard tie. There is some risk of injury when teaching a horse to tie. Is it ok to hard tie your horse? Yes or No

There is some risk of injury when training a horse to do new things. We recommend having your horse insured, but this is not required.

FEES: Current Training Rate: \$1200/mo. \$600 for board due at drop off plus \$45.00/training session due at pick up. Most horses benefit from 4-5 training sessions a week.

HORSES PHYSICAL CONDITION:

You must have proof of a recent flu/rhino vaccine, a dental exam in the past 6 months and a parasite prevention program. *Physical Condition:* Prior to arrival the boarder confirms that the horse is not showing any unusual signs of illness. Signs may be yellowish snotty nose with discharge, high temperature or neurological signs. The boarder also confirms that the horse has not visited any stables/arenas/ranches where a recent outbreak of a virus of any kind has taken place in the last 30 days. Please notify RM RANCH HORSES if the horse has visited any areas with recent outbreaks or showing any signs of illness. INITIAL: _____

VERERINARY CARE:

Boarder agrees and understands that it is the Boarder's responsibility to provide Horse with proper veterinary care and veterinary services. Boarder understands that if Boarder's horse is or appears sick or injured, RM RANCH HORSES will first try to contact the Boarder. If Boarder is unavailable, or Horse has an emergency as deemed by RM RANCH HORSES, Boarder gives RM RANCH HORSES permission to call Boarder's veterinarian, identified as:

I take full responsibility for myself, my family members, and for any guest that I may bring onto the property and will not hold RM RANCH HORSES, it's owners, agents, or employees responsible for accident or injury to myself, my family members, my guest, or my agents. INITIAL: _____
